Parents, teachers, students, and school staff were engaged in the development of this plan and other COVID fund plans through various surveys. We found that school surveys were the most conducive for families during COVID-19 to ensure their safety and the safety of school staff. Surveys centered around extended learning opportunities, academic and social-emotional needs, and school improvement. Students participated in surveys such as the social-emotional survey and climate survey to help with development.

Following safety measures, synchronous and in-person meetings were used to disseminate information on COVID funds and planned uses of these funds. Weekly staff meetings, Academic Leadership Team (ALT), Administrative Team Meetings (ATM), and Executive Team Meetings facilitate discussions around the use of these funds as more data and safety regulations come to light and how best to support both student learning and school safety. Our student leadership team (grade level representatives) assisted in providing student needs at monthly meetings.

Families have also participated in the development of the plan through monthly Cafecito, School Board Meetings, and School Site Council. Educational partners at these meetings review school data and make recommendations.

From the community, we work closely with Desert Mountain Special Education Local Plan Area (DM SELPA) to review the needs their office is observing within the community and how they can help our school address these needs, providing support for staff and families.

A virtual community meeting was extended to educational partners, including any tribes and civil rights organizations as applicable, asking for additional input. This meeting held on December 17, 2021, was the last call for input on the use of ESSER III funds from the school's educational partners. Attendees were represented by parents. The specific educational partners that were invited, tribes and civil rights organizations, did not attend to provide input. The opportunity to provide input was made available to attendees through Zoom's chat and dialogue features.

Based on educational partner's feedback, student safety during in-person learning and learning not addressed while distanced led to the following planned expenditures:

- extended learning opportunities including summer academy and tutoring
- social-emotional learning curriculum
- technology and materials for quarantine, at home students
- furniture for social distancing
- additional sanitation supplies
- substitute teacher availability
- health technician
- anti-bullying safety measures
- independent study availability
- suicide prevention curriculum
- enrichment opportunities
- professional development for secondary teachers in ELD
- supplemental curriculum to build reading skills

An additional community meeting on December 17, 2021, asked for additional input from educational partners including representatives from tribes and civil rights organizations. Comments from parents were positive and questions addressed items already in the budget.

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;
